NOTES: All FIS users can initiate the transfer of files from the unclassified (OCF) network to the classified (SCF) network. Only approved SNSI users can initiate the transfer of files from the OCF to SNSI (**SNSI to SCF transfers are not allowed**). Submitting the files for transfer from the SCF or SNSI to the OCF requires membership in a FIS Derivative Classifier (DC) pool (Section D). Files submitted to a pool are reviewed for content by a DC and, if determined to be unclassified, are promoted for transfer to a corresponding OCF location.

Use of the FIS does not exempt users from the Information Management process. Authors are responsible for ensuring all data is appropriately reviewed in accordance with DOE Order 241.1 prior to release or distribution outside LLNL.
